**Driving Lesson Scheduling & Cancellation:** Lessons will be scheduled in advance. Students may reschedule one driving lesson with 48 hours notice. Any lessons rescheduled without 48 hours notice will be subject to additional payment.

**Class D Driving Permits:** Must be held for 6 months from date of issuance before road skills test can be performed.

**Medical Conditions:** Certain medical conditions, physical, neurological, emotional or mental that inhibits a person's ability to drive safely may require approval by the State of Alaska DMV before driving, testing or licensing. Any condition must be disclosed to KPDI. Failure to disclose this information is unsafe for both the student and the instructor.

**Non-driving courses:** Payment in full must be made a minimum of 5 business days prior to the start of the course. Refunds will be given only if instructor cancels the class.

**All driving courses:** Full fee due at time of scheduling. Full Refund will be given for cancellations prior to 10 business days. Scheduled courses may be cancelled due to nonparticipation or at the discretion of Kenai Peninsula Driving Instruction.

*Prerequisites and DMV Fees are the responsibility of the student.*

Thank you for hiring us for your road examination. We are a third party tester for the State of Alaska DMV. **The fee for this service is non-refundable.** There should not be any audio or video recording devices, cell phones or cameras of any type turned on during the road test.

We use the DMV scoring rubric and follow the DMV road test manual. You may be disapproved by accumulation of points, dangerous driving actions, breaking traffic law or being unable to perform a basic maneuver such as parallel parking. If you do one of these things the test will end. A disapproved road test will not qualify for a refund. You may choose to retest after the mandatory waiting period and the testing fee will apply for the new test.

As third party testers the DMV may opt to retest you to evaluate our testing procedures. If this is requested there will be no cost to you for the retest. The DMV has the right to request this at any time.

By signing below you certify that you are:

- 16 years of age or older
- Have held a Class D Instruction permit for six or more months if under age 18.
- Have NOT been in an accident, been issued any citations including minor consuming alcohol.
- Have NOT been court ordered to have an interlocking ignition devices installed in any vehicle you drive
- Have NOT taken a Class D road examination in the last 7 days with the DMV or any third party tester.
- Do not have a medical condition that will put myself, my examiner or others at risk.
